The Fall General Meeting of the Clearview Lake Property Owners' Association will be held on September 24, 2018. We will vote on the annual budget. The proposed budget does not include a dues increase. Plan on attending and working towards a better community. See below for the agenda and details.

DUES MUST BE PAID BY IN FULL BY SEPTEMBER 30 to avoid a \$50 annual late fee and collections action by our attorney. In case you misplaced your bill, Homeowners owe \$545 and Lotowners owe \$230 for the year. Thank you to those members who pay promptly!

Road repairs have been completed for the year. There is much more we would like to do, both for our safety and for property values. Almost 15% of our dues go uncollected every year. \$15,000 annually could go directly towards road improvements. The extra road work that we have done has been funded by collections, fines and judgements from delinquent dues. Did you pay your dues? Are your neighbors paying their dues? Ask yourself those questions before you complain about the roads.

Bus stop safety – if you feel you must meet your kid's bus, please park well back from the corner on Tooley and Cypress. These are narrow roads with limited visibility. It's hard enough to turn the corner when no one is parked there and if two cars meet, it can be nearly impossible. With cars parked close to the corner children who aren't being met are forced to walk down the center of the road, increasing the danger. Please stay well back from the corner.
